COMES NOW the City of Bellevue, by and through its attorney of record, McHugh Bromley, PLLC, and hereby files this *Notice of Appearance* in response to this Court's *Procedural Order*, dated January 6, 2017. The *Procedural Order* was issued in response to the Sun Valley Company's December 23, 2016 *Petition for Judicial Review*, seeking judicial review of the Director of the Idaho Department of Water Resources' November 3, 2016 *Order Denying Petition for Declaratory Ruling* ("Final Order"). The Director's Final Order was issued in response to the Sun Valley Company's July 25, 2016 *Petition for Declaratory Ruling Regarding Creation of ESPA Ground Water Management Area*, as amended by Sun Valley Company on

October 19, 2016. On October 5, 2016, the City of Bellevue timely petitioned to intervene in the underlying administrative proceeding, and was served with the Final Order. While the Director did not address intervention in the Final Order, the Director subsequently granted intervention to the City of Bellevue on December 27, 2016 in his *Order Granting Petitions to Intervene* (IDWR Docket No. P-DR-2016-001).

The *Procedural Order* states that “a party to the underlying administrative proceeding is not made a named party . . . may file a *Notice of Appearance* in this matter within fourteen (14) days from the issuance of the *Procedural Order*. This Court will treat the *Notice of Appearance* as a *Motion to Intervene* and will treat the party filing the *Notice of Appearance* as an Intervenor.” *Procedural Order* at 2 (footnote omitted).

The City of Bellevue hereby respectfully notices the Court of its appearance in this proceeding.
