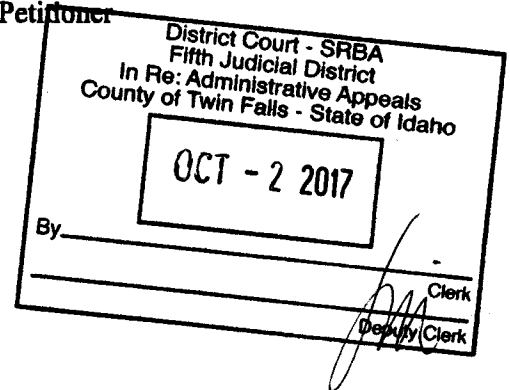

**STIPULATED AGREEMENT
FOR REMAND**

This Stipulation is entered into by and between Petitioner, Seven High Ranch, Inc. ("Seven High Ranch"), and Respondent, the Idaho Department of Water Resources ("IDWR").

A. Seven High Ranch filed this action on September 21, 2017, requesting judicial review pursuant to I.C. § 67-5270 of the final order of IDWR approving Transfer No. 81188 in the name of Seven High Ranch.

B. Seven High Ranch is aggrieved by the omission of certain conditions in the approval of Transfer No. 81188.

C. The parties desire to enter into the following agreement providing for the matter to be remanded to IDWR for the purpose of considering the objections raised by Seven High Ranch to the final order approving Transfer No. 81188.

**IN CONSIDERATION OF THE PROMISES STATED, THE PARTIES AGREE
AS FOLLOWS:**

1. The proceeding on appeal to the District Court shall be remanded to IDWR for consideration of the objections raised by Seven High Ranch in the Petition for Judicial Review.
2. Following consideration of the matter on remand, IDWR shall enter an order addressing the issues raised by Seven High Ranch.
3. Upon implementation of this agreement through entry of an order by IDWR on remand, the parties shall move to dismiss the appeal before the District Court unless Seven High Ranch remains aggrieved and elects to proceed with this action for judicial review.
4. The parties agree to bear their own fees and costs.
