On January 15, 2025, the parties filed a stipulated motion requesting the Court issue an order staying this proceeding until December 31, 2027. The Motion is filed pursuant to the terms of the 2024 Stipulated Mitigation Plan and the Director’s Final Order Approving Stipulated Mitigation Plan, which both provide the parties shall request a stay of litigation of the above-captioned case during the term of the 2024 Stipulated Mitigation Plan. The Court in an exercise of its discretion will grant the stipulated motion to extend on the basis it is unopposed.

THEREFORE, BASED ON THE FOREGOING, THE FOLLOWING ARE HEREBY ORDERED:

1. The stipulated motion to extend the stay is hereby granted.
2. All proceedings in the above-captioned matter are stayed until December 31, 2027.
3. Notice is hereby given that a status conference in the above-captioned matter is set for December 21, 2027, at 1:30 p.m. (MT) at the Snake River Basin Adjudication Courthouse, 253 – 3rd Avenue North, Twin Falls, Idaho. Parties may participate in person or remotely through telephone or video conference using the remote meeting application ZOOM.
