PETITIONERS' MOTION FOR STAY BASED ON IDWR'S INTERFERENCE WITH LAWFUL DISCOVERY IN THE MATTER OF THE DISTRIBUTION OF WATER TO VARIOUS WATER RIGHTS HELD BY AND FOR THE BENEFIT OF A&B IRRIGATION DISTRICT, AMERICAN FALLS RESERVOIR DISTRICT #2, BURLEY IRRIGATION DISTRICT, MILNER IRRIGATION DISTRICT, MINIDOKA IRRIGATION DISTRICT, NORTH SIDE CANAL COMPANY, AND TWIN FALLS CANAL COMPANY

Petitioners, the Cities of Idaho Falls, Pocatello, Jerome, Burley, Bliss, Carey, Declo, Dietrich, Gooding, Hazelton, Heyburn, Paul, Richfield, Rupert, Shoshone, and Wendell; and McCain Foods USA, Inc. (collectively, the "Petitioners"), by and through their respective counsel, hereby move the Court pursuant to Idaho Code § 67-5274 and Rule 84(m) of the Idaho Rule of Civil Procedure to stay the hearing set for June 6-10, 2023, in IDWR Docket No. CM-DC-2010-001, until this Court rules on the Petition for Judicial Review of May 5, 2023 Discovery Order ("Petition") filed herewith. The Petition seeks a ruling from this Court that the Idaho Department of Water Resources' ("Department" or "IDWR") assertion of a "deliberative process" privilege in the context of the Director's Order Denying Appointment of Independent Hearing Officer and Motion for Continuance and Limiting Scope of Depositions ("Discovery Order"), and Department counsel's invocation of the alleged privilege during depositions of Department staff, is inconsistent with Idaho law. The Department's interference with discovery in this manner has prevented Petitioners from conducting investigations related to relevant information in the above-captioned proceeding. As a matter of law, the "deliberative process" privilege is not available as a defense to disclosure or discovery in the State of Idaho, and the Department cannot use it as a shield to prevent discovery of relevant information. This motion is supported by Petitioners' Memorandum in Support of Motion for Stay Based on IDWR's Interference with Discovery filed herewith.
