Bonneville County Case No. CV10-24-2909**



IT IS FURTHER ORDERED that the assignment of this case to Fifth District Judge ERIC WILDMAN shall be considered an appointment by the Idaho Supreme Court and that, pursuant to Idaho Rule of Civil Procedure 40(d), there shall be no right to disqualify ERIC WILDMAN without cause in this case.

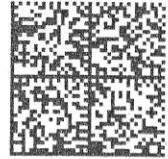
