The quantity under this water right is limited to up to 44.10 acre feet per year, with a diversion rate never to exceed the lesser of 1.00 CFS or twenty-five (25) percent of the rate of flow then available at each point of diversion and, cumulatively, no more than twenty-five (25) percent at the furthest downstream point of diversion in use under water right nos. 94-09547A thru 94-09582E.

Right nos. 94-09562A, 94-09562B and 94-09562C are limited to a total combined annual diversion volume of 44.10 acre feet.

PLACE OF USE: National Forest System Land in the Iron Creek-Little North Fork Coeur d'Alene River subwatershed (HUC12 170103010601), Sage Creek subwatershed (HUC12 170103050301), Hayden Creek subwatershed (HUC12 170103050101), Yellowbanks Creek-Hayden Lake subwatershed (HUC12 170103050102), Gold Creek subwatershed (HUC12 170102140201), Independence Creek subwatershed (HUC12 170103010203), Trail Creek subwatershed (HUC12 170103010202) and Burnt Cabin Creek-Little North Fork Coeur d'Alene River subwatershed (HUC12 170103010602).

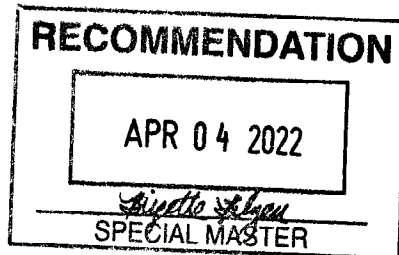
OTHER PROVISIONS NECESSARY FOR DEFINITION OR ADMINISTRATION OF THIS WATER RIGHT:

This right is limited to the intermittent diversion and use of water for the stated purposes. This water right shall not be used as a basis to prevent the future appropriation of water or the basis to request or initiate a delivery call or otherwise have the Idaho Department of Water Resources, a Water District or a Court curtail or limit distribution in whole or in part, to existing legal uses of water to satisfy this water right. This provision shall not be construed as a basis to curtail the United States' use of water under this right to satisfy junior water rights.

This partial decree is subject to such general provisions necessary for the definition of the rights or for the efficient administration of the water rights as may be ultimately determined by the Court at a point in time no later than entry of a final unified decree. Idaho Code § 42-1412(6).

With respect to the issues determined by the above partial judgment it is hereby CERTIFIED, in accordance with Rule 54(b), I.R.C.P., that the court has determined that there is no just reason for delay of the entry of a final judgment and that the court has and does hereby direct that the above partial judgment is a final judgment upon which execution may issue and an appeal may be taken as provided by the Idaho Appellate Rules.
