I. FINDINGS OF FACT

A notice of claim was filed for this water right pursuant to I.C. § 42-1411A by the United States as Trustee for the Nez Perce Tribe. The Nez Perce Tribe joined in the claim. The Director of the State of Idaho Department of Water Resources examined the water system for this reporting area. The *Director's Report* contained an Abstract of the claim for the elements of this water right.

Objections were filed by Jacob and Ginger Osborn; the State of Idaho, PotlatchDeltic Land and Lumber, LLC; PotlatchDeltic Forest Holdings, Inc.; and Potlatch TRS Idaho, LLC.

United States' Motion to Withdraw Claim was filed on June 4, 2025. A hearing was held on July 16, 2025. At the hearing, the United States as Trustee argued the Motion to Withdraw Claim, and the Nez Perce Tribe joined in the Motion.

No parties to the subcase opposed the *Motion to Withdraw Claims*. The Court granted the *Motion. Order Granting Motion to Withdraw Claims*. (July 25, 2025)

II. CONCLUSIONS OF LAW


THEREFORE, based on the file and record herein, IT IS RECOMMENDED that this water right **not be confirmed** in any partial or final decree.


