Court discusses document received from Mr. Gallant in regard to relinquishing these listed water rights and what it entails. Court advises that the wording does make this document a bit harder to understand as it does not specifically state that the water rights are being transferred. Court requests clarification from Mr. Gallant. Mr. Gallant agrees that he is transferring the water rights to Mr. Chandler. Mr. Chandler agrees and states that they wanted to make sure they had something notarized and on file with the Court.

02:14:50	Court asks IDWR for clarification on whether the document received would be sufficient to allow the department to process a change of ownership. Ms. Ramell-O'Brien advises that there would need to be more time to confer with staff on whether this is a proper conveyance. The Court states that while it is odd to have a transfer or purchase of water rights without a transfer or purchase of property, it is something that can be worked through.
