On January 23, 2026, the United States filed *United States' Motion to Withdraw Claim* in subcase 87-12006. The U.S. explained that it obtained new information from a site visit and determined it no longer seeks to maintain this claim. Therefore, the U.S. moved to withdraw this claim. A hearing was held Feb. 25, 2026. At the hearing, the Nez Perce Tribe joined in the *Motion*.

The parties to this subcase did not oppose the *Motion to Withdraw Claim*. Therefore, the *Motion to Withdraw Claim* for 87-12006 is **granted with prejudice**. Accordingly, a ***Special Master's Report*** will issue consistent with this decision.
