On January 27, 2026, the Nez Perce Tribe filed a *Motion to Withdraw Provisional Claims* in Subcase Nos. 87-12160, 87-12164, and 87-12175. A hearing was held on February 25, 2026. At the hearing, the Nez Perce Tribe explained it obtained new information during recent site visits and no longer wished to maintain claims in these subcases. Therefore, the Nez Perce Tribe moved to withdraw its claims.

The parties to these subcases did not oppose the *Motion to Withdraw Claims*. Therefore, the *Motion to Withdraw Claims* for these subcases is **granted with prejudice**. A *Special Master's Report* will issue consistent with this decision.
