E. REASONS SUPPORTING OBJECTION(S):

Claimant's claims are improperly stacked in violation of I.C. 42-111(2), and the quantity reported in the Director's Report is insufficiently described.

Claimant has filed thirty-four claims for stockwater use within one ranching unit, *see* Attachment A, asserting a collective water use that far exceeds the amount that can be obtained through the *de minimis* deferral process. For these thirty-four claims, twenty-eight are for 6,860 cattle and six are for 1,446 cattle. A *de minimis* stockwater use is limited to historical beneficial use up to a maximum of thirteen thousand gallons-per-day ("gpd"), which can serve the needs of approximately 1,000 head of range cattle under IDWR's guidelines. Each of the thirty-four claims thus asserts a use that is greater than *de minimis*.

Further, IDWR's recommendation, which omits the number of cattle on each claim under explanatory material, would allow Claimant to stack its individual deferred claims to achieve a total use that far exceeds the *de minimis* limit. The Court's Order Governing Procedures in the SRBA for Adjudication of Deferred *De Minimis* Domestic and Stock Water Claims (Jun. 28, 2012) requires that "[c]laimants of deferred *de minimis* domestic or stock water rights may not claim an amount in excess of" 13,000 GPD, utilizing the *de minimis* standard established in I.C. 42-111(1)(a).¹ I.C. 42-111(2) states that multiple water rights for domestic uses or domestic purposes – which encompasses *de minimis* livestock watering, *see* I.C. 42-111(a) - shall not be established or exercised in a manner to satisfy a single combined water use or purpose that would not itself come within the *de minimis* limitation. The livestock operation at Claimant's ranch is a single combined water use or purpose.

Accordingly, Claimant can only obtain a maximum of 13,000 gpd of stockwater across the claims for each ranching unit. The thirty-four stacked claims would not be a *de minimis* use, and should have been claimed in the main phase of the SRBA. If the 6,860 cattle asserted on each claim is intended to identify the number of cattle associated with this one ranch, then that is also not *de minimis*. For multiple deferred claims serving a single combined water use on one ranch, a combined use remark should be added to preclude stacking of deferred claims in violation of I.C. 42-111(2). BLM's objection would be resolved by addition of the following remark:

The use of water under the following rights is limited to a total combined use of 0.02 cfs and 13,000 gpd: 37-23270, 37-23273, 37-23274, 37-23275, 37-23276, 37-23283, 61-12361, 61-12362, 61-12363, 61-12368, 61-12369, 61-12370, 61-12371, 61-12375, 61-12376, 61-12380, 61-12382, 61-12383, 61-12387, 61-12388, 61-12389, 61-12396, 61-12398, 61-12400, 61-12401, 61-12403, 61-12405, 61-12407, 61-12440, 61-12489, 61-12490, 61-12491, 61-12492, 61-12536.

¹ I.C. 42-111(a) defines domestic purposes or domestic uses to mean "[t]he use of water for ... livestock, and for any other purpose in connection therewith, including irrigation of up to one-half (1/2) acre of land, if the total use does not exceed thirteen thousand (13,000) gallons per day."


